  - 6.1.1 The Board discussed how to ensure the tour of the Anderson Dam Seismic Retrofit Project is in compliance with the Brown Act given that the public cannot participate as it is an active Valley Water construction site. The consensus of the Board was to request that Valley Water allow the Directors to tour in groups of a maximum of two Directors at a time, and that Director comments not be shared or relayed until the Board convenes as a whole at a future monthly Board meeting so that the public can hear the comments and other feedback so as to participate in any subsequent discussion.
