Project Name: **Urban Gray Fox Corridor Project**

Modification Requested (for example, change in project; change in scope of services, change in term of the agreement; change in budget): This is an alteration in the original collaring project.

Justification for Request: In the original request for the Collaring Project, we assumed that we could pull together anywhere from between 12 and 15 young gray foxes, collar them, then track them when they dispersed. This would pinpoint those areas of the Baylands and possibly beyond where and into what kind of territory those foxes dispersed. By so doing, we would have had a good idea as to where to restore or develop linkages between varied habitats in the Baylands. Our intent was to create a network of corridors that would improve the health of all wildlife along the San Francisco Bay.

However, given the massive die-out in November and December of 2016 of all 25 gray foxes living between Adobe Creek and San Francisquito Creek due to canine distemper, and the fact that not enough new fox pairs took up residence in the Baylands, we could not produce the necessary 12 – 15 gray fox pups needed for the Collaring Project.

As such, we have moved ahead to develop a new restoration project that will link existing habitat and create new habitat for not only the gray foxes but all wildlife living and thriving along the edge of the San Francisco Bay presently between the Facebook Campus and Moffett Field. In that light, we are working with the City of Mountain View on their **Wildlife Management Plan** and with **Facebook** to establish a viable corridor along the San Francisco Bay.
